

RACA BILLING AND STRUCTURE OF FEES

RACA believes that fees charged for services rendered or proposed to be rendered shall depend on the nature of the matter to be attended to, whether contentious or non-contentious and shall be charged according to **The Advocates Remuneration Order** or as agreed and or negotiated between the parties and in the case of dispensation—while taking into consideration **The Advocates (Professional Conduct and Etiquette) Regulations**. The Advocates Remuneration Order and The Advocates (Professional Conduct and Etiquette) Regulations can be accessed through our website downloads section for further reference. However, the following table stipulates the charges that can be billed on the named cases:

4	Case before Tax Revenue Board (TRAB)	Specific rates will depend on the nature of the case.	Will be charged as per statutory rate or fixed rate agreed
5	Case before Tax Revenue Tribunal (TRAT)	Specific rates will depend on the nature of the case.	Will be charged as per statutory rate or fixed rate agreed
6	Case before the Court of Appeal of Tanzania	Specific rates will depend on the nature of the case.	USD 12500 (Negotiable)
7	Legal Opinion	Specific rates will depend on the nature of the case.	USD 1500 (Negotiable)
8	Non-Contentious Matters	Specific rates will depend on the nature of the case.	USD 5000 (Negotiable)

Notwithstanding the fee structure in the foregoing, charges for delivering advice, opinions or similar services shall be fixed as stated in the **Notaries Public and Commissioners for Oaths Notice** and RACA's Billing and Structure of Fees. Unless agreed otherwise and considering the time to be spent in delivering the requested services, complexity, size and activities involved in the task, the fees may be revised downward or escalated after consultation with the client. RACA will take into consideration, while providing such services, the circumstances, urgency and category of the services to be provided on fixed or capped, volume discounts or standard fees agreement.

In addition, for work charged on an hourly rate, the charges shall be subject to the table below:
